**WDOH CLOSURE / OPENING CRITERIA: A zone is closed when one or more of the six crab in the sample are 30 ppm or higher in the viscera, or 20 ppm or higher in meat. Reopening a zone closed due to toxic test results, will require two (2) consecutive crab sample sets, not less than seven (7) days apart, with all six crab in each set, testing below 30 ppm in the viscera, or 20 ppm in meat.**
