**Deadline to Apply – December 31, 2007**

Your award will be based on California Department of Fish and Game records. This was calculated by comparing your 2002–2006 total Chinook Salmon poundage to the State of California’s 2002–2006 total for Chinook Salmon poundage. Your total will also include \$500.00 for a license rebate.

If you can substantiate this loss, sign this application verifying that it is accurate and true and understand that you may be subject to a federal audit.

Pacific States Marine Fisheries Commission will distribute relief money for the California share of the Federal Salmon Disaster Relief Program. For California the total maximum allocation for all Commercial Wholesale Fish Dealers Lost Income is \$6 million.
