Washington Coastal Commercial Dungeness Crab Fishery Industry Notice

Please note the following:

- The primary Quinault SMA switches to the smaller secondary Quinault SMA on June 1st (as described below).
- The 200 pot limit in the area between Split Rock and Raft River is in effect on June 1st (as described on page 2).
- The 100 pot limit in the Quileute SMA remains in place through May 31st (as described on page 2).

SPECIAL MANAGEMENT AREAS:

Quinault:

The Quinault **primary SMA** remains closed to state fishers through 8:00 a.m. June 1, 2012.

The Quinault **primary SMA** is described as the coastal waters shoreward of a line approximating the 27-fathom depth curve between Raft River (47°28.00) and Copalis River (47°08.00) according to the following coordinates:

•	Northeast Corner:	47°28.00 N. Lat.	124° 20.70 W. Lon.
٠	Northwest Corner:	47°28.00 N. Lat	124°34.00 W. Lon.
٠	Southwest Corner:	47°08.00' N. Lat.	124°25.50' W. Lon.
•	Southeast Corner:	47°08.00' N. Lat.	124° 11.20' W. Lon.

A Quinault **secondary SMA** (SSMA) will be established at 8:00 a.m. on June 1, 2012 to include the area shoreward of a line approximating the 27-fathom depth curve between the mouth of the Copalis River (47°08.00) and Split Rock (47°24.50) according to the following coordinates:

•	Northeast Corner (Split Rock):	47°24.50' N. Lat.	124°20.00' W. Lon.
٠	Northwest Corner:	47°24.50' N. Lat.	124°32.40' W. Lon.
٠	Southwest Corner:	47°08.00' N. Lat.	124°25.50' W. Lon.
•	Southeast Corner (Copalis River):	47°08.00' N. Lat.	124°11.20' W. Lon.

There is a 200-pot limit in the area between Split Rock (47°24.50) and Raft River (47°28.00) shoreward of a line approximating the 27-fathom depth curve from 8:00 a.m. June 1, 2012, through 8:00 a.m. June 30, 2012. Fishers must pre-register with WDFW prior to deploying gear in this area by one of the three following methods:

Quileute:

The Quileute SMA opened to state fishers beginning at 8:00 AM, May 1, 2012.

The Quileute SMA is described as the area from Cape Johnson to Destruction Island shoreward of a line approximating 30 fathoms according to the following points:

٠	Northeast Corner (Cape Johnson):	47°58.00' N. Lat	124°40.40' W. Long.
٠	Northwest Corner:	47°58.00' N. Lat	124°49.00' W. Long.
٠	Southwest Corner:	47°40.50' N. Lat.	124°40.00'W. Long.
٠	Southeast Corner: (Destruction Island);	47°40.50' N. Lat.	124° 24.43 W. Long.

There is a 100-pot limit in the SMA from May 1, 2012, through May 31, 2012. Fishers must pre-register with WDFW prior to deploying gear in this area by one of the three following methods:
