Fishery managers met today to determine the opening structure for the west coast commercial Dungeness crab fishery. In response to low pick-out rates for crab in Washington and Northern California areas, the opening of the Oregon Dungeness crab fishery will be delayed another 15 days and open in Oregon as follows:
