# WASHINGTON COASTAL DUNGENESS CRAB INDUSTRY NOTICE

## **Summer Fishery Management**

With the intent of protecting crab in the soft-shelled condition, the following provisions of the Coastal Dungeness Crab Summer Fishery Management Plan will be in effect at 12:01 A.M. July 6, 2025, through the end of the season:

# It is unlawful for any person licensed to fish under a coastal Dungeness crab fishery license to <u>possess</u> or <u>land</u> crab in excess of <u>2.500 pounds</u> during any weekly catch accounting period (Sunday through Saturday). See the list of catch accounting periods below.

Any crab taken prior to July 6, 2025, and not landed before 11:59 P.M., July 5, 2025, will be considered part of the July 6 through July 12, 2025, accounting period catch.

#### Weekly Catch Accounting Periods:

- July 6 July 12, 2025
- July 13 July 19, 2025
- July 20 July 26, 2025
- July 27 August 2, 2025
- August 3 August 9, 2025
- August 10 August 16, 2025

- August 17 August 23, 2025
- August 24 August 30, 2025
- August 31 September 6, 2025
- September 7 September 13, 2025
- September 14 September 15, 2025

## **MORE INFORMATION:**

Weekly trip limits as dictated by the Summer Fishery Management Plan protect Washington State's Dungeness crab resource from handling mortality. Permanent implementation of the 2,500-pound limit on July 1 has been in place since 2015. To avoid confusion, the weekly landing limit will always start on the first Sunday in July. WDFW will continue to collect shell condition data through the remainder of the season both dockside and atsea and will take additional measures following the Plan's sampling protocols if large numbers of soft-shelled crab are present. WDFW relies on consenting commercial fishers to collect at-sea shell condition data. If you are contacted about scheduling a ride along trip, please do your best to accommodate our request. If at-sea shell condition data cannot be collected as outlined in the Summer Fishery Management Plan, a reduced weekly landing limit will be considered regardless of crab condition.

## **<u>14-day Landing Rule</u>**

As a reminder, beginning May 1 through September 15, it is <u>unlawful to leave Dungeness crab pots deployed</u> in Grays Harbor, Willapa Bay, Columbia River, or waters of the Pacific Ocean adjacent to the state of Washington for more than 14 consecutive days without making a Dungeness crab landing. This gear tending requirement ensures that gear that is not being actively fished is removed from the water as well as contributes to efforts to

reduce entanglements with marine mammals by minimizing gear in the water during the period when whales are more likely to be present off the Washington Coast. • Vessels leaving the fishery must submit a departure report to WDFW <u>before</u> turning off their EM system. Departure reports must contain vessel name, license number, and departure date.
