### CMSP Implementation: What To Expect?

- GCC sets 8 Regional Planning Bodies (RPBs): Fall '11
- RFMCs submit comment letter (6/11)
- RPBs draft Regional Plans:1 yr
- RPBs formalize Plans: 2-3 yrs
- NOC approves plans <u>consistent with National Policy</u>
- RPB Plan Implementation: 4-5 yrs
- Existing agreements between States included (?)
- States may elect to "opt out" of the Regional Plans (?)

### Magnuson-Stevens Act (MSA) Chronology Post Reauthorization

- MSA reauthorization late 2006
- NOAA Implementation Framework ongoing
- House Natural Resources Subcommittee on Insular Affairs, Oceans & Wildlife 1<sup>st</sup> MSA Oversight (10/09)
- Post-reauthorization LAPPs (WC groundfish; MA tilefish; GOMEX snapper/grouper; "Sectors" in New England)
- 2010 "MARCH ON WASHINGTON" by approx 3,000 commercial/sport fishermen calling for MSA reform and opposing LAPPs
- Overfishing & ACL/AM requirements online 2010-11

#### MSA Activities: Senate

- Senate Commerce Committee hearings on NOAA
   OLE (3/10) & MSA Implementation (3/11)
- Legislation: "RI Fishermen's Fairness Act" (Reed; D-RI); "Asset Forfeiture Fund Responsibility Act" & "Fishing Impact Statement Honesty Act" (Sen. Brown; R-MA); "Flexibility in Rebuilding American Fisheries Act" (Sen. Schumer; D-NY); "Fisheries Fee Fairness Act" (Sen. Kerry; D-MA)
- No MSA in 2011 but more reform legislation anticipated along with a NOAA OLE/Catch Share hearing in Fall 2011

- Next up... MSA legislative hearing (9/11)

#### National Catch Share Policy

- NOAA finalizes Policy (11/10)
- Primary purpose "is to encourage well-designed catch share programs to help maintain or rebuild fisheries, and sustain fishermen, communities and vibrant working waterfronts, including the cultural and resource access traditions that have been a part of this country since its founding."

## Catch Share Policy: Bottom-up Management or Seeds of Controversy?

The following legend appeared on a map of catch share programs in NOAA's initial National Catch Share Policy PowerPoint Presentation to the RFMCs in Summer/Fall 2009 (it has since been omitted ...)

- 12 Programs in place now
- 5 Scheduled to be implemented in FY 2011
- 32 Additional Programs will begin development in FY 2012

#### National Catch Share Controversy Heats Up...

- IFQ programs implemented since 2006 MSA amendments – West Coast Groundfish;
   GOMEX Snapper-Grouper; Mid-Atlantic Tilefish; Northeast Cod "Sector" Management
- Litigation abounds
- EDF initiates well-funded national pro-catch share campaign; recruits "fishing" groups
- Mistrust of EDF & NOAA's "bottom up" approach

### Catch Share Policy: Fire in the Hole!

- The FY11 "Jones Amendment" (2/11)
- Triggers EDF full court press for FY12
- NOAA legal opinion on Amendment (4/11)
- Commercial, Charter,Sport sectors engage

- Year-long battle over a Rep. Jones repeat in FY12
- Impacts new LAPPs in Northeast, Mid, Southeast, GOMEX
- Pro/Con Member letters & West Coast briefing in US Capitol

### Catch Share Programs: Where Do We Stand?

- EDF-funded groups cover Capital Hill weekly with pro-catch share ads/flyers
- GOMEX commercial/charter/sport sectors respond with aggressive lobby campaign
- Rep. Runyan's H.R. 2772 protects jobs & curtails new LAPPs (8/11)
- FY12 Funding for LAPPs...TBD!
