
Where We Are in 2014

FY 2015 Budget Status & Schedule

President's Budget

- Released March 4th
- NOAA's Blue Book released March 13^{th:} <u>http://1.usa.gov/1eAb77G</u>

Commerce, Justice, Science (CJS) Appropriations Bills

- House Mark: HR. 4660 passed on May 30, 2014
- Senate Mark: passed full committee on June 5, 2014
 - Senate appropriations process for CJS put on hold...

Schedule

- Congress is out on summer recess; back September 8, 2014
- Continuing resolution likely



FY 2015 Budget Status – House

- H.R.4660 Commerce, Justice, Science, and Related Agencies Appropriations Act, 2015 passed on May 30, 2014.
 - \$5.3B for NOAA (\$151.6M below FY15 discretionary request and \$22.5M above FY 14).
 - NMFS funded at \$855.6M for Discretionary Accounts
 - \$790.2M for ORF (5.6% below FY15 discretionary request and 2.8% below FY14).
 - Funds NWS operations and systems above the President's request.
 - Fully funds JPSS weather satellite program and GOES.



FY 2015 Budget Status – Senate

- The full Senate Appropriations Committee passed its FY 2015 CJS Appropriations Bill on June 5, 2014.
 - \$5.4B for NOAA (\$68.7M below FY15 discretionary request and \$105.4M above FY 14)
 - Urges balance across ocean, coastal, and weather programs
 - Supports NWS above FY15 request
 - More supportive of NOAA wet side proposals
 - NMFS funded at \$901.5M for Discretionary Accounts
 - \$836.2M for ORF (0.1% below FY15 discretionary request and 3.3% above FY14)



Summary of FY15 House and Senate Marks

- House Mark
 - -Provided \$892.3 million for ORF
 - \circ \$24.5 million (2.7%) below the FY 2015 request
 - \circ \$104.7 million (10.5%) below the FY 2014 Spend Plan
- Senate Mark
 - -Provided \$938.3 million for ORF
 - \circ \$21.5 million (2.3%) above the FY 2015 request
 - \circ \$58.7 million (5.9%) below the FY 2014 Spend Plan



FY 2015 House Mark – NMFS Highlights

- PCSRF is \$65M, \$15M above FY15 President's Budget, level with FY 2014.
- Includes a modification to the proposed language in General Provisions for reimbursable authority.
- Habitat funded at \$25.0M, \$17.2M below FY 15 President's Budget and \$16.7M below FY 2014 Spend Plan – No funding for habitat restoration.



FY 2015 Senate Mark – NMFS Highlights

- PCSRF is \$65M, \$15M above FY15 President's Budget, level with FY 2014, and the House Mark.
- Includes a modification to the proposed language in General Provisions for reimbursable authority – same as House Mark.
- Habitat funded at \$52.2M, \$10.0M above FY 15 President's Budget and \$10.6M above FY 2014 Spend Plan. \$30.9M of this is funding for habitat restoration.

Proposed FY 2015 NMFS Budget Increases

- Species Recovery Grants: + \$5.0 M (\$10.0 M Requested)
 - House provided \$7.0 M (\$3.0M below request)
 - Senate provided \$5.0 M (\$5.0 M below request)
- Other Protected Species [ESA Implementation]: + \$4.0 M (\$11.1 M Requested)
 - House provided \$10.0 M (\$1.1 M below request)
 - Senate provided \$10.2 M (\$0.9 M below request)
- Atlantic Salmon: + \$1.0 M (\$6.1 M Requested)
 - House provided \$4.0 (\$2.1 M below request)
 - Senate provided \$6.0 (\$0.07 M below request)
- Fisheries Research and Management Programs: + \$4.0 M (\$181.8 M Requested)
 - House provided \$176.7 M (\$5.1 M below request)
 - Senate provided \$177.0 M (\$4.8 M below request)



Proposed FY 2015 NMFS Budget Increases

- National Catch Share Program: + \$2.0 M (\$27.2 M Requested)
 - House provided \$20.0 M (\$7.2 M below request)
 - Senate provided \$25.0 M (\$2.2 M below request)
- Expand Annual Stock Assessments: + \$2.5 M (\$72.2 M Requested)
 - House provided \$72.0 (\$0.2M below request)
 - Senate provided \$72.0 (\$0.2M below request)
- Climate Regimes & Ecosystem Productivity: + \$0.8 M (\$2.9 M Requested)
 - House provided \$2.0 M (\$0.9 M below request)
 - Senate provided \$2.5 M (\$0.4 M below request)



Proposed FY 2015 NMFS Budget Decreases

- Prescott Grant Program and Marine Mammal Protection: \$2.5 M (\$12.0 M requested)
 - House provided 11.8M (\$0.2 M below request)
 - Senate provided \$13.8 M (\$1.8 M above request)
- Hawaiian Sea Turtles: -\$1.0 M (\$4.2 M requested)
 - House provided for full reduction
 - Senate provided \$5.0 M (\$0.8 M above request)
- Salmon Management: -\$3.0 M (\$27.3 M requested)
 - House provided \$30.0 M (\$2.7 M above request)
 - Senate provided \$30.2 M (\$2.9 M above request)
- Pacific Coastal Salmon Recovery Fund: -\$15.0 M (\$50.0 M requested)
 - House provided \$65.0 M (\$15 M above request)
 - Senate provided \$65.0 M (\$15 M above request)
- Fishery Disaster Mitigation Fund: -\$75.0 M (\$0 M requested)
 - House and Senate both provided for full reduction

Outlook for FY 15

- Potential for continuing resolution
 - Mid-year elections
 - End of fiscal year
- Fiscal uncertainty will continue

 - Congressional appropriations language




National Program Activities cont'd:

Saltonstall-Kennedy Grants Program: FY 2014 and FY 2015

- NMFS is currently developing the funding priorities for the combined FY14/15 S-K grant solicitation.
 - Priorities for S-K are based on NMFS Priorities document.
 - They have been cross-checked with each of the Council's 5-year research plans.
 - NMFS has also reviewed available Commission research plans to ensure their priorities were reflected.
 - On Congressional direction, this year we added a priority about Community-based Bridge Plans.
 - The S-K Priorities are currently under internal review.
 - Soon NMFS will formally solicit input from the Councils, Commissions, and States on the priorities.
- Anticipate publishing the formal solicitation later this fall for between \$15 M and \$20 M

— Ensure productivity and sustainability of fisheries and fishing communities through science-based decision-making and compliance with regulations. — Recover and conserve protected resources through use of sound natural and social sciences.
