

Magnuson-Stevens Act (MSFCMA)

- NOAA revising NSG's 1-3-7; Proposed Rule (6/15)
- NOAA revising National Bycatch Strategy (7/15)
- NOAA implementing "Prioritizing of Fish Stock Assessments" (Final Report, 8/5/15 at <u>http://www.st.nmfs.noaa.gov/stock-assessment/stock-assessment-prioritization</u>; concurrently revising Stock Assessment Improvement Plan (SAIP)
- NOAA issues Nat'l Habitat Policy (6/15); EFH Summit to be mediated by Fisheries Forum (5/16);
- NMFS releases Regional Electronic Technology Plans (2/8/15)
- NOAA/NMFS OLE rescinds 2011 AFF policy, institutes new policy effective 7/15/15
- D-Crab legislation: S.1143;H.R. 2168; House Nat Res Subcom hearing 7/23/15 positive; possible movement separate from MSFCMA reauthorization...

MSA Reauthorization: House

- House Natural Resources Committee moves H.R. 1335 "Strengthening Fishing Communities and Increasing Flexibility in Fisheries Management Act" (5/29/2015)
- GOMEX Red Snapper complications
- House passes "clean" H.R. 1335 (vote of 225-152; 6/1/2015)
- Administration issues veto threat
- **OUTLOOK**: House waits on Senate...

MSA Reauthorization: Senate

- Commerce Subcommittee Chairman Marco Rubio (FL-R) introduces S.1403 – "Florida Fisheries Improvement Act"; moved by full committee (6/25/2015); bipartisan opposition (AK/WA)
- S.1403 limited in scope; unclear if the bill is a reauthorization bill; more red snapper woes?
- **OUTLOOK**: Unlikely to get to the Senate floor in 2015; unclear if Member(s) offer competing legislation...reauthorization unlikely in 2015...start here in 2016...

- 70+ commercial/recreational groups request no FY16 funding for EBM & CMSP (4/15); Since 2012 ~ 2 doz. votes by Congress to trim \$\$\$ & scope of NOP
- CEQ to announce NOC/GCC appointments; WCGA/RPB merging to form pseudo-RPB "West Coast Ocean Partnership"; NE/MID RPB's project 2016 plan completion

Climate Change #1


- Administration seeking global climate treaty (11/14; to be signed in 2015?)
- WH CEQ issues revised draft guidance for federal agencies for consideration of greenhouse gas emissions under NEPA for federal resource management actions (79 FR 77801; 12/24/14)
- NOAA/NMFS release 81-pg Draft Climate Science Strategy (1/15); See (http://www.st.nmfs.noaa.gov/ecosystems/climate/natio nal-call-for-comments); Regional Plans in 2015?

Climate Change #2

- DOI, USDA, EPA, NOAA, USACE announce Resilient Lands & Waters Initiative sites in CA and MT to prepare natural resources for climate change (2015)
- Admin announces #1 FY2017 budget priority: *Climate Change* (7/15)
- Admin mandates steep cuts in greenhouse gas emissions; 32% by 2030, from 2005 levels; costs to U.S. power plants ~ \$8.40B per year (8/2/15)
- President to visit Alaska on 8/31 to attend Arctic Conference; focus on climate change; MAJOR announcement? See <u>www.wh.gov/Alaska</u>

Sanctuaries, Monuments & MPAs

- NOAA/NOS petition process (79 FR 33851; 6/14) leads to nominations off AK, OR, FL – all rejected, lack local support
- NOAA/NOS Summer 2015 "Sanctuary Watch: Coalition Building" highlights new petition process www.nominate.noaa.gov
- H.R. 1335 provision specifies MSA as the controlling law in cases of statutory conflict (i.e. NMSA, ESA, Antiquities Act)
- NOAA updates Framework for a National System of MPAs (2/15)
- S.437; H.R.330; H.R.332 -- all contain provisions designed to limit Administration's executive authority
- NOAA expands Cordell Bank & Gulf of Farallones Sanctuaries (3/15; 80 FR 13078) linkage with Point Arena Nat'l Marine Monument (4/14); reinforces Admin's theme of <u>connectivity</u> of protected areas; MPA Advisory Panel charged with developing national connectivity plan (4/15)

- H.R. 564; WA Rep. Herrera Beutler/OR Rep. Schrader's "Endangered Salmon & Fisheries Predation Prevention Act"; State removal permits effective to 5/16; House Nat Res Subcom hearing (7/23/15)
- NOAA announces Species in the Spotlight: Survive to Thrive initiative, focus on 8 species, most in PSMFC region (incl. So. Res. Killer Whales, Belugas, Pacific Leatherbacks; 5/14/15)
- So. Res. Killer Whales: NGO petition to increase Critical Habitat from Cape Flattery, WA to Point Reyes, CA out to 47 miles (80 FR 9682; 2/24/15); ESA listing "*LOLITA*" at Miami Seaquarium (80 FR 7380; 2/10/15); NMFS completes tracking project (6/15); Nat Geo documentary under development
- NOAA proposes 14 DPS of global humpbacks; revises ESA listings (80 FR 22304; 4/21/15)
- NOAA Report *Threatened & Endangered Species FY 2013-2014 Report* to Congress (5/14/15)

- House Nat Res Comtee 36-pg Majority Report "Under the Microscope: An Examination of the Questionable Science and Lack of Independent Peer Review in ESA Listing Decisions" (12/15/15); See <u>http://naturalresources.house.gov</u>
- NMFS publishes comment request on guidelines for safely deterring marine mammals (79 FR 74710; 12/16/14)
- NGOs sue NMFS to ban seafood imports from countries that do not protect marine mammals to U.S. MMPA standards (7/14); Agency settles (1/15); proposed standards issued 8/10; See 80 FR 48172; comments due 11/9/15
- CBD petition to Congress "*Don't let Big Industry Gut the ESA*", collects 63,308 signatures
- NGOs request CA take *urgent* action to prevent whale entanglements in Dungeness crab & other fixed-gear fisheries (4/15)

Protected, Endangered, Threatened Species #3

- USFWS/NMFS issue FR revising ESA ITS provisions to address use of surrogate species (80 FR 26832; 5/11/15)
- USFWS/NMFS issue PR to revise ESA petition regs (80 FR 29286; 5/21/15; comments due 9/18/15)
- NMFS initiates 5-yr review of 32 listed species of Pacific Salmon, Steelhead, Puget Sound Rockfish & Euchalon (80 FR 6695; 2/6/15)
- NOAA Regional Science Center peer reviews continue; (<u>http://www.st.nmfs.noaa.gov/science-program-review/index</u>) – <u>FY15 topic: Protected Resources Science</u>
- Senate EPW Committee reviews 7 ESA bills (5/6/15), similar to pkg passed by the House Nat Res in 2014; House has 2 in the cue
- Recovering Predators Creates New Wildlife Management Challenges <u>http://www.nwfsc.noaa.gov/news/features/recovering_predators/in</u> <u>dex.cfm</u>

EPA NPDES Update

- Moratorium on EPA NPDES permits sunsets 12/19/2017 for all commercial fishing & charter boats regardless of size, and all commercial-use vessels <79-ft
- Senate Commerce Committee moves USCG bill (S.1611) w/Sen. Rubio's S.373 attached amid opposition (i.e. CA & WA); H.R. 980 similar; AK's S.371 – permanent "clean" moratorium
- WA/OR/CA renew opposition (4th letter; 7/2/15)
- Admin opposes (RE: ballast water & state jurisdiction provisions, <u>and</u> permanent NPDES permit fix)
- Outlook: Highly controversial, likely see action in 2017...

USCG Update

- Class A/B Automatic Identification System (AIS) required on all vessels over 65-ft (3/2/16)
- Mandatory Dockside Safety Exams required (10/15/15); and at least 1X every 5yrs
- Survival Craft requirements ensuring "no part of an individual is immersed in water" effective 2/16/16; H.R. 1987 requires USCG study and exemptions; S.1611 <u>does</u> <u>not</u> contain similar provisions
- House/Senate USCG legislation: relaxing new-build classification requirements; expanding Fisheries Finance Program (FFP)
- Newport, OR USCG helo base closure up in the air

IUU Fishing & Seafood Fraud

- Final Report on the IUU Task Force available at <u>http://www.nmfs.noaa.gov/ia/iuu/noaa_taskforce_report_final.pdf</u>; open comment period on species "at-risk" for fraud to 9/11/15
- Developing "minimum types of information that should be collected and the operational standards that should be applied to this data" to prevent IUU fishing/seafood fraud; <u>https://www.federalregister.gov/articles/2015/07/01/2015-</u> <u>16185/presidential-task-force-on-combating-illegal-unreported-andunregulated-iuu-fishing-and-seafood</u>
- House passes IUU H.R. 774; Senate Commerce moves companion S.1334; 2015 passage likely...
- Seafood safety/traceability legislation (H.R. 3282); multi-committee referral; 2015 passage unlikely...
- State Dept sends \$4.3M to Asia-Pacific Region to combat IUU (8/15)

Aquatic Invasive Species

- Lake Tahoe Restoration Act (S.1724; 7/15) does <u>not</u> contain quagga Lacey Act injurious species listing <u>or</u> exemption for public water systems
- Next steps find legislative (or regulatory) vehicle for quagga listing & resolve public water systems exemption
- Federal Lands Invasive Species Control Act (H.R. 1485; 3/15) requires agencies to reduce invasive species
- Similar bill did not move in 2014, current bill has 2 sponsors: Amodei (R-NV) & Lummis (R-WY)
- AIS issues present in NPDES S.373 & H.R.980

Catch Share/Allocation Update

- NMFS phasing-out West Coast IFQ observer subsidies on 9/30/15; See NMFS letter at <u>https://www.webapps.nwfsc.noaa.gov/ifq/</u>
- "Review of Laws, Guidance, Technical Memorandums and Case Studies Related to Fisheries Allocations"; NOAA Tech Memo NMFS-F/SPO-148 (11/14)
- GOMEX Red Snapper allocation issues complicate MSA reform & D-Crab legislation
- H.R.2646/S.1275: "Revitalizing the Economy of Fisheries in the Pacific Act" ("REFI") for 2003 West Coast buyback loans; stalled due to fiscal issues; Sense of Congress in 2015 Defense Authorization; NMFS PR comment period ends 9/8 (on 8/6 @ 80 FR 46941) – *final action contingent on 3 referenda PLUS \$10.3M federal appropriation...*


SHARK/HUMAN INTERACTIONS #1

Recent decades marked by substantial national/regional shark conservation; significantly reduced quotas/landings since the 1980's (~ 90%), harvest of 5 species prohibited (1997), 14 more added (2000); Shark Conservation Act (2010); CITES protects 5 commercially-valuable sharks (2013); AP bans phrase "shark attack" (2013); NGOs/Cuba conservation campaign; France bans shark meat @ Reunion Isle (1990's) & creates marine reserve (2007); Hilton bans shark fin soup; proliferation of ESA petitions; efforts at Congressional Resolutions; "U.S. leads the way...strongest shark management measures in the world" (NOAA, 7/8/15); 9 States ban fins, CA wins fin ban lawsuit (7/15); Cordell Banks/Gulf of Farallones Sanctuary expansion adds Great White Protection Zone (2015); NGOs launch #SaveGreatWhites Challenge with Hammermill Paper Co. (2015); FL (1992) & NC (2005) create inshore shark "sanctuaries" banning most shark fishing creating HAPC (from DSF; Hudson, R., 2015; "Shark Sanctuaries: Unintended Consequences from Underfishing and Overregulation")

SHARK/HUMAN INTERACTIONS #2

- FL Museum Nat Hist Internat'l Shark Attack File (*ISAF*): worldwide "number of unprovoked attacks grows every decade since the 1970s"
- MASS exploding seal pop.= tourism concerns/attracting sharks to beaches; tagging ongoing (*Aol.com*); So. Africa world surfing tourney cancelled due to attack on live T.V.(7/15); France's Reunion Isle -- 18 attacks/7 fatal – Gov't bans swimming in 2013 (*NYT*; 8/11/15)
- U.S. deadliest year 2011, 13 of 79 attacks fatal (*ISAF*); In 2015, 25 attacks thru July 4th wknd, one fatal (HI) and in NC -- most attacks (8) already recorded for full year; U.S. has top rated (and 5 of the top 10) highest risk locations in the world (2 are in FL, plus CA, HI & SC) (*Aol.com*); 5 fatalities in Australia, January 2015; Worldwide 54 attacks/31 fatalities thru 8/19/15 (*Fox News; 8/19/15*)
- Top 3 reasons media cites for increased attacks -- global warming; more people in the water (est. 2.0BM in 2001, 2.2B in 2010, by USACE); and "swimming near tasty bait fish" (*Science*, 7/2/15)
- Due in part to unbalanced mgmt policies -- or simply that "encounters with marine animals such as sharks [are] inevitable as long as people keep visiting their habitat" (*G.Skomal/aol.com; 6/17/15*)?
